Dear Parent/Guardian,

**Your child's flu vaccination is now due**

This vaccination is recommended to help protect your child against flu. Flu can be an unpleasant illness and can cause serious complications. Vaccinating your child will also help protect more vulnerable family and friends by preventing the spread of flu.

Even if your child had the vaccine last year, the type of flu can vary each winter, so it is recommended to have it again this year or they won't be protected.

Since the programme was introduced, most children offered the vaccine in schools have had the immunisation.

This academic year the School Age Immunisation Service are vaccinating students from Reception to Year 11 and up to Year 13 in special schools. Any young person who has had a consent form submitted and is outside of these year groups will not be vaccinated and the consent will be removed.

**NOTE**, the consent form must be completed by someone with Parental Responsibility or Delegated Authority\* – please see the explanations of these terms at end of this letter.

Most children are offered a nasal spray vaccine which is a quick, simple and painless spray up the nose. This is the preferred vaccine. A link to the leaflet explaining the vaccination programme can be found at the bottom of the page, this includes details about the small number of children for whom the nasal vaccine is not appropriate.

The nasal spray vaccine contains a very small amount of gelatine from pigs (porcine gelatine) as an essential ingredient to keep it stable and able to work. For those who may not accept medicines or vaccines that contain porcine gelatine, a flu vaccine injection is available.

**If your child becomes wheezy, has a bad attack of asthma, or has started oral steroids for their asthma after you return this form, please contact the School Age Immunisation Service on 0300 124 0366.**

If you decide you do not want to vaccinate your child against flu, please return the consent form giving the reason. This will inform us of your wishes to non-consent and help us plan and improve the service. A non-return of the consent form does not mean a non-consent.

**\*PARENTAL RESPONSIBILITY:**
